MINUTES BOARD OF REAL ESTATE APPRAISERS March 7, 2024 Colorado Division of Real Estate Meeting Conducted Via Webinar

A Colorado Board of Real Estate Appraisers public meeting was conducted via Webinar and was held on Thursday, March 7, 2024.

Notice of the meeting was published timely and the meeting was held pursuant to the Colorado Sunshine Laws, Title 24, Article 6, C.R.S., as amended.

ORDER OF BUSINESS BY THE CHAIR:

Call to Order, Roll Call, Determination of a Quorum-

The meeting was called to order at 9:01 a.m. by Chris Chippindale, Acting Chair. Melissa Phipps, Senior Advisor made a quorum determination.

POLICY MATTERS:

Appraiser Accountability through Engagement Letter Terms & Conditions -

The issue of appraiser accountability through engagement letter terms and conditions was introduced by Mr. Taylor for Board discussion. Following discussion in Executive Session, it was determined by the Board that this is a legal issue that BOREA is unable to address.

At 9:13 a.m. it was moved, seconded and approved by more than two-thirds vote by the Board that pursuant to \$24-6-402(3)(a)(II), C.R.S., to convene the Colorado Board of Real Estate Appraisers into Executive Session for the purpose of receiving legal advice pursuant to C.R.S. \$24-6-402(3)(a)(II) concerning disputes that are the subject of pending or imminent court action and/or for the purpose of receiving legal advice regarding Policy Matter A -Appraiser Accountability through Engagement Letter Terms & Conditions.

COMPLAINT INVESTIGATIONS:

NOTE: Mr. Taylor recuses himself from consideration of Complaint #2023-1882 and leaves the webinar.

A. Complaint No. 2023-2139 (Robert Walker, Investigator)

Melissa Phipps, Senior Advisor, presented this matter to the Board.

The report alleged violations of: §12-10-613(1)(g) C.R.S.; §12-10-710(1)(h) C.R.S.; §12-10-614(1)(g) C.R.S.; USPAP violations include Scope of Work Rule; Record Keeping Rule; Ethics Rule; Standard Rule 1 and Standard Rule 2.

Mr. Goff moved and Ms. Glassburn seconded that the Board finds reasonable grounds exist to believe that violations of appraisal law occurred in Complaint No. 2023-2139. The Board voted to refer back to Staff for a settlement offer for a Stipulation and Final Agency Order to include coursework of 6 or more hours in Site Valuation; 7 or more hours in Residential Income Approach; and a 15-hour National USPAP course. In addition, the respondent will be required to be supervised for a period of a minimum of four months and complete 12 appraisals.

B. Complaint No. 2023-2392 (Robert Walker, Investigator)

Melissa Phipps, Senior Advisor, presented this matter to the Board.

The report alleged violations of: \$12-10-613(1)(g) C.R.S.; \$12-10-613(1)(j) C.R.S.; Board Rule 12.12; USPAP violations include Scope of Work Rule; Record Keeping Rule; Ethics Rule; Standard Rule 1 and Standard Rule 2.

Ms. Glassburn moved and Mr. Goff seconded that the Board finds reasonable grounds exist to believe that violations of appraisal law occurred in Complaint No. 2023-2392. The Board voted to refer back to Staff for a settlement offer for a Stipulation for Diversion to include coursework of 7 or more hours in Comparative Analysis and/or Supporting Adjustments; 15 hours in Residential Report Writing and Case Studies; 5 or more hours in Data Verification; and 7 hours in Back to Basics - Fixing Dangerous Habits. In addition, the respondent will be required to submit to Work Product Review of 5 appraisals in two months.

Motion unanimously carried.
