Tangible Net Benefit Disclosure Request -

Following introduction by Deputy Director Eric Turner, the Board discussed the request from Rocket Mortgage to modify the timing requirement for when a Tangible Net Benefit Disclosure is required to be provided to consumers. Based on the discussion of the Board, Division staff will initiate a stakeholder group and will draft a rule if the process determines it has merit.

LICENSING MATTERS:

A. Complaint #2024-665 (DM) - Preliminary Advisory Opinion -

The Board considered this application for a preliminary advisory opinion for a mortgage loan originator's license together with accompanying documentation and information supplied by the applicant.

On November 30, 2006, the applicant was convicted of Tax Evasion and Aiding and Abetting, a Felony. The applicant was ordered to serve 90 days in jail, pay \$370,570.00 in restitution and complete three years of probation. Probation was completed on April 27, 2010. The remaining balance on the restitution is \$353,705.29 and monthly payments of \$10.00 are ongoing.

It was moved by Ms. Falbo and seconded by Ms. Meckstroth to issue a negative opinion based on §12-10-711(2)(b)(1), C.R.S.

Motion unanimously carried.

Attorney General Matters:

A. Complaint #2024-125 (BH) - Settlement Proposal -

Following discussion in Executive Session, it was moved by Ms. Falbo and seconded by Ms. Emerine to approve the settlement offer in Complaint #2024-125 (BH) and to delegate authority to the Division of Real Estate to prepare and sign a Stipulation and Final Agency Order on behalf of the Board. The Final Agency Order will include voluntary relinquishment of the respondent's MLO license, public censure and a fine in the amount of \$1,000 (+ 15% mandatory surcharge).
