**2.5.2. Inclusions – Not Attached.** If on the Property, whether attached or not, on the date of this Contract, the following items are included unless excluded under **Exclusions**: storm windows, storm doors, window and porch shades, awnings, blinds, screens, window coverings and treatments, curtain rods, drapery rods, fireplace inserts, fireplace screens, fireplace grates, heating stoves, storage sheds, carbon monoxide alarms, smoke/fire detectors and all keys.

**2.5.3. Other Inclusions.** The following items, whether fixtures or personal property, are also included in the Purchase Price:

128 **3.2. Applicability of Terms.** If any deadline blank in § 3.1. (Dates and Deadlines) is left blank or completed with “N/A”,  
129 or the word “Deleted,” such deadline is not applicable and the corresponding provision containing the deadline is deleted. Any box  
130 checked in this Contract means the corresponding provision applies. If no box is checked in a provision that contains a selection of  
131 “None”, such provision means that “None” applies.

132 The abbreviation “MEC” (mutual execution of this Contract) means the date upon which both parties have signed this Contract. The  
133 abbreviation “N/A” as used in this Contract means not applicable.

134 **3.3. Day; Computation of Period of Days; Deadlines.**

135 **3.3.1. Day.** As used in this Contract, the term “day” means the entire day ending at 11:59 p.m., United States  
136 Mountain Time (Standard or Daylight Savings, as applicable). –Except however, if a **Time of Day Deadline** is specified in § 3.1.  
137 (Dates and Deadlines), all Objection Deadlines, Resolution Deadlines, Examination Deadlines and Termination Deadlines will end  
138 on the specified deadline date at the time of day specified in the **Time of Day Deadline**, United States Mountain Time. If **Time of**  
139 **Day Deadline** is left blank or “N/A” the deadlines will expire at 11:59 p.m., United States Mountain Time.

140 **3.3.2. Computation of Period of Days.** In computing a period of days (e.g., three days after MEC), when the  
141 ending date is not specified, the first day is excluded and the last day is included.

142 **3.3.3. Deadlines.** If any deadline falls on a Saturday, Sunday or federal or Colorado state holiday (Holiday), such  
143 deadline  Will  Will Not be extended to the next day that is not a Saturday, Sunday or Holiday. Should neither box be checked,  
144 the deadline will not be extended.

145 **4. PURCHASE PRICE AND TERMS.**

146 **4.1. Price and Terms.** The Purchase Price set forth below is payable in U.S. Dollars by Buyer as follows:

147 **4.2. Seller Concession.** At Closing, Seller will credit to Buyer \$ \_\_\_\_\_ (Seller Concession). The Seller  
148 Concession may be used for any Buyer fee, cost, charge or expenditure to the extent the amount is allowed by the Buyer’s lender  
149 and is included in the Closing Statement or Closing Disclosure at Closing. Examples of allowable items to be paid for by the Seller  
150 Concession include, but are not limited to: Buyer’s closing costs, loan discount points, loan origination fees, prepaid items and any  
151 other fee, cost, charge, expense or expenditure. Seller Concession is in addition to any sum Seller has agreed to pay or credit Buyer  
152 elsewhere in this Contract.

153 **4.3. Earnest Money.** The Earnest Money set forth in this Section, in the form of a \_\_\_\_\_, will be  
154 payable to and held by \_\_\_\_\_ (Earnest Money Holder), in its trust account, on behalf of  
155 both Seller and Buyer. The Earnest Money deposit must be tendered, by Buyer, with this Contract unless the parties mutually agree

156 to an **Alternative Earnest Money Deadline** for its payment. The parties authorize delivery of the Earnest Money deposit to the  
157 company conducting the Closing (Closing Company), if any, at or before Closing. In the event Earnest Money Holder has agreed to  
158 have interest on Earnest Money deposits transferred to a fund established for the purpose of providing affordable housing to Colorado  
159 residents, Seller and Buyer acknowledge and agree that any interest accruing on the Earnest Money deposited with the Earnest  
160 Money Holder in this transaction will be transferred to such fund.

161 **4.3.1. Alternative Earnest Money Deadline.** The deadline for delivering the Earnest Money, if other than at the  
162 time of tender of this Contract, is as set forth as the **Alternative Earnest Money Deadline**.

163 **4.3.2. Disposition of Earnest Money.** If Buyer has a Right to Terminate and timely terminates, Buyer is entitled  
164 to the return of Earnest Money as provided in this Contract. If this Contract is terminated as set forth in § 24 and, except as provided  
165 in § 23 (Earnest Money Dispute), if the Earnest Money has not already been returned following receipt of a Notice to Terminate,  
166 Seller agrees to execute and return to Buyer or Broker working with Buyer, written mutual instructions (e.g., Earnest Money Release  
167 form), within three days of Seller's receipt of such form. If Seller is entitled to the Earnest Money, and, except as provided in § 23  
168 (Earnest Money Dispute), if the Earnest Money has not already been paid to Seller, following receipt of an Earnest Money Release  
169 form, Buyer agrees to execute and return to Seller or Broker working with Seller, written mutual instructions (e.g., Earnest Money  
170 Release form), within three days of Buyer's receipt.

171 **4.3.2.1. Seller Failure to Timely Return Earnest Money.** If Seller fails to timely execute and return the  
172 Earnest Money Release Form, or other written mutual instructions, Seller is in default and liable to Buyer as set forth in "**If Seller  
173 is in Default**", § 20.2. and § 21, unless Seller is entitled to the Earnest Money due to a Buyer default.

174 **4.3.2.2. Buyer Failure to Timely Release Earnest Money.** If Buyer fails to timely execute and return the  
175 Earnest Money Release Form, or other written mutual instructions, Buyer is in default and liable to Seller as set forth in "**If Buyer  
176 is in Default, § 20.1. and § 21**", unless Buyer is entitled to the Earnest Money due to a Seller Default.

177 **4.4. Form of Funds; Time of Payment; Available Funds.**

178 **4.4.1. Good Funds.** All amounts payable by the parties at Closing, including any loan proceeds, Cash at Closing  
179 and closing costs, must be in funds that comply with all applicable Colorado laws, including electronic transfer funds, certified  
180 check, savings and loan teller's check and cashier's check (Good Funds).

181 **4.4.2. Time of Payment.** All funds, including the Purchase Price to be paid by Buyer, must be paid before or at  
182 Closing or as otherwise agreed in writing between the parties to allow disbursement by Closing Company at Closing **OR SUCH  
183 NONPAYING PARTY WILL BE IN DEFAULT**.

184 **4.4.3. Available Funds.** Buyer represents that Buyer, as of the date of this Contract,  **Does**  **Does Not** have  
185 funds that are immediately verifiable and available in an amount not less than the amount stated as Cash at Closing in § 4.1.

186 **4.5. New Loan.**

187 **4.5.1. Buyer to Pay Loan Costs.** Buyer, except as otherwise permitted in § 4.2. (Seller Concession), if applicable,  
188 must timely pay Buyer's loan costs, loan discount points, prepaid items and loan origination fees as required by lender.

189 **4.5.2. Buyer May Select Financing.** Buyer may pay in cash or select financing appropriate and acceptable to  
190 Buyer, including a different loan than initially sought, except as restricted in § 4.5.3. (Loan Limitations) or § ~~2930~~ (Additional  
191 Provisions).

192 **4.5.3. Loan Limitations.** Buyer may purchase the Property using any of the following types of loans:  
193  **Conventional**  **FHA**  **VA**  **Bond**  **Other** \_\_\_\_\_.

194 If either or both of the FHA or VA boxes are checked, and Buyer closes the transaction using one of those loan types, Seller agrees  
195 to pay those closing costs and fees that Buyer is not allowed by law to pay not to exceed \$ \_\_\_\_\_.

196 However, this amount does not include any compensation to be paid to Buyer's brokerage firm.

197 **4.5.4. Loan Estimate – Monthly Payment and Loan Costs.** Buyer is advised to review the terms, conditions and  
198 costs of Buyer's New Loan carefully. If Buyer is applying for a residential loan, the lender generally must provide Buyer with a  
199 Loan Estimate within three days after Buyer completes a loan application. Buyer also should obtain an estimate of the amount of  
200 Buyer's monthly mortgage payment.

201 **4.6. Assumption.** Buyer agrees to assume and pay an existing loan in the approximate amount of the Assumption Balance  
202 set forth in § 4.1. (Price and Terms), presently payable at \$ \_\_\_\_\_ per \_\_\_\_\_  
203 including principal and interest presently at the rate of \_\_\_\_\_ % per annum and also including escrow for the following as

206 Buyer agrees to pay a loan transfer fee not to exceed \$ \_\_\_\_\_. At the time of assumption, the new interest rate will

211 Seller  **Will**  **Will Not** be released from liability on said loan. If applicable, compliance with the requirements for release  
212 from liability will be evidenced by delivery  on or before **Loan Transfer Approval Deadline**  at **Closing** of an appropriate  
213 letter of commitment from lender. Any cost payable for release of liability will be paid by \_\_\_\_\_ in an amount

215 This Contract terminates if written consent from Seller's lender for Buyer's assumption of Seller's existing loan is not received  
216 by all parties and the Closing Company on or before Closing.

217 **4.7. Seller or Private Financing.**

218 **WARNING:** Unless the transaction is exempt, federal and state laws impose licensing, other requirements and restrictions on sellers  
219 and private financiers. Contract provisions on financing and financing documents, unless exempt, should be prepared by a licensed  
220 Colorado attorney or licensed mortgage loan originator. Brokers should not prepare or advise the parties on the specifics of financing,  
221 including whether or not a party is exempt from the law.

222 **4.7.1. Seller Financing.** If Buyer is to pay all or any portion of the Purchase Price with Seller financing,  **Buyer**  
223  **Seller** will deliver the proposed Seller financing documents to the other party on or before \_\_\_\_\_ days before **Seller or**  
224 **Private Financing Deadline.**

225 **4.7.1.1. Seller May Terminate.** If Seller is to provide Seller financing, this Contract is conditional upon  
226 Seller determining whether such financing is satisfactory to the Seller, including its payments, interest rate, terms, conditions, cost,  
227 and compliance with the law. Seller has the Right to Terminate under § 24.1., on or before **Seller or Private Financing Deadline**,  
228 if such Seller financing is not satisfactory to Seller, in Seller's sole subjective discretion.

229 **4.7.2. Buyer May Terminate.** If Buyer is to pay all or any portion of the Purchase Price with Seller or private  
230 financing, this Contract is conditional upon Buyer determining whether such financing is satisfactory to Buyer, including its  
231 availability, payments, interest rate, terms, conditions, and cost. Buyer has the Right to Terminate under § 24.1., on or before **Seller**  
232 **or Private Financing Deadline**, if such Seller or private financing is not satisfactory to Buyer, in Buyer's sole subjective discretion.

233 **TRANSACTION PROVISIONS**

234 **5. FINANCING CONDITIONS AND OBLIGATIONS.**

235 **5.1. New Loan, Assumption Application.** If Buyer is to pay all or part of the Purchase Price by obtaining one or more  
236 new loans (New Loan), or if an existing loan is not to be released at Closing, Buyer, if required by such lender, must make an  
237 application verifiable by such lender, on or before **New Loan Application Deadline** and exercise reasonable efforts to obtain such  
238 loan or approval.

239 **5.2. New Loan Terms; New Loan Availability.**

240 **5.2.1. New Loan Terms.** If Buyer is to pay all or part of the Purchase Price with a New Loan, this Contract is  
241 conditional upon Buyer determining, in Buyer's sole subjective discretion, whether the proposed New Loan's payments, interest  
242 rate, conditions and costs or any other loan terms (New Loan Terms) are satisfactory to Buyer. This condition is for the sole benefit  
243 of Buyer. Buyer has the Right to Terminate under § 24.1., on or before **New Loan Terms Deadline**, if the New Loan Terms are not  
244 satisfactory to Buyer, in Buyer's sole subjective discretion.

245 **5.2.2. New Loan Availability.** If Buyer is to pay all or part of the Purchase Price with a New Loan, this Contract is  
246 conditional upon Buyer's satisfaction with the availability of the New Loan based on the lender's review and underwriting of Buyer's  
247 New Loan Application (New Loan Availability). Buyer has the Right to Terminate under § 24.1., on or before the **New Loan**  
248 **Availability Deadline** if the New Loan Availability is not satisfactory to Buyer. Buyer does not have a Right to Terminate based on the  
249 New Loan Availability if the termination is based on the New Loan Terms, Appraised Value (defined below), the Lender Property  
250 Requirements (defined below), Insurability (§ 10.5. below) or the Conditional Upon Sale of Property (§ 10.7. below). **IF SELLER IS**  
251 **NOT IN DEFAULT AND DOES NOT TIMELY RECEIVE BUYER'S WRITTEN NOTICE TO TERMINATE, BUYER'S**  
252 **EARNEST MONEY WILL BE NONREFUNDABLE**, except as otherwise provided in this Contract (e.g., Appraisal, Title,  
253 Survey).

254 **5.3. Credit Information.** ~~If an existing loan is not to be released at Closing, this~~ This Contract is conditional (for the sole  
255 benefit of Seller) upon Seller's approval of Buyer's financial ability and creditworthiness, which approval will be in Seller's sole  
256 subjective discretion. Accordingly: (1) Buyer must supply to Seller by **Buyer's Credit Information Deadline**, at Buyer's expense,  
257 information and documents (including a current credit report) concerning Buyer's financial, employment and credit condition; (2)  
258 Buyer consents that Seller may verify Buyer's financial ability and creditworthiness; and (3) any such information and documents  
259 received by Seller must be held by Seller in confidence and not released to others except to protect Seller's interest in this transaction.  
260 If the Cash at Closing is less than as set forth in § 4.1. of this Contract, Seller has the Right to Terminate under § 24.1., on or before  
261 Closing. If Seller disapproves of Buyer's financial ability or creditworthiness, in Seller's sole subjective discretion, Seller has the  
262 Right to Terminate under § 24.1., on or before **Disapproval of Buyer's Credit Information Deadline**.

263 **5.4. Existing Loan Review.** ~~If an existing loan is not to be released at Closing,~~ Seller must deliver copies of the loan  
264 documents (including note, deed of trust and any modifications) to Buyer by **Existing Loan Deadline**. For the sole benefit of Buyer,  
265 this Contract is conditional upon Buyer's review and approval of the provisions of such loan documents. Buyer has the Right to  
266 Terminate under § 24.1., on or before **Existing Loan Termination Deadline**, based on any unsatisfactory provision of such loan  
267 documents, in Buyer's sole subjective discretion. If the lender's approval of a transfer of the Property is required, this Contract is  
268 conditional upon Buyer obtaining such approval without change in the terms of such loan, except as set forth in § 4.6. If lender's  
269 approval is not obtained by **Loan Transfer Approval Deadline**, this Contract will terminate on such deadline. Seller has the Right

270 to Terminate under § 24.1., on or before Closing, in Seller's sole subjective discretion, if Seller is to be released from liability under  
271 such existing loan and Buyer does not obtain such compliance as set forth in § 4.6.

272 5.5. Buyer Representation of Principal Residence. Buyer represents that Buyer will NOT occupy the Property as Buyer's  
273 principal residence.

274 **6. APPRAISAL PROVISIONS.**

275 **6.1. Appraisal Definition.** An "Appraisal" is an opinion of value prepared by a licensed or certified appraiser, engaged on  
276 behalf of Buyer or Buyer's lender, to determine the Property's market value (Appraised Value). The Appraisal may also set forth  
277 certain lender requirements, replacements, removals or repairs necessary on or to the Property as a condition for the Property to be  
278 valued at the Appraised Value.

279 **6.2. Appraised Value.** The applicable appraisal provision set forth below applies to the respective loan type set forth in  
280 § 4.5.3., or if a cash transaction (i.e., no financing), § 6.2.1. applies.

281 **6.2.1. Conventional/Other.** Buyer has the right to obtain an Appraisal. If the Appraised Value is less than the  
282 Purchase Price, or if the Appraisal is not received by Buyer on or before **Appraisal Deadline** Buyer may, on or before **Appraisal**  
283 **Objection Deadline:**

284 **6.2.1.1. Notice to Terminate.** Notify Seller in writing, pursuant to § 24.1., that this Contract is terminated;  
285 or

286 **6.2.1.2. Appraisal Objection.** Deliver to Seller a written objection accompanied by either a copy of the  
287 Appraisal or written notice from lender that confirms the Appraised Value is less than the Purchase Price (Lender Verification).

288 **6.2.1.3. Appraisal Resolution.** If an Appraisal Objection is received by Seller, on or before **Appraisal**  
289 **Objection Deadline** and if Buyer and Seller have not agreed in writing to a settlement thereof on or before **Appraisal Resolution**  
290 **Deadline**, this Contract will terminate on the **Appraisal Resolution Deadline**, unless Seller receives Buyer's written withdrawal of  
291 the Appraisal Objection before such termination, (i.e., on or before expiration of **Appraisal Resolution Deadline**).

292 **6.2.2. FHA.** It is expressly agreed that, notwithstanding any other provisions of this Contract, the purchaser (Buyer)  
293 shall not be obligated to complete the purchase of the Property described herein or to incur any penalty by forfeiture of Earnest  
294 Money deposits or otherwise unless the purchaser (Buyer) has been given, in accordance with HUD/FHA or VA requirements, a  
295 written statement issued by the Federal Housing Commissioner, Department of Veterans Affairs, or a Direct Endorsement lender,  
296 setting forth the appraised value of the Property of not less than \$ \_\_\_\_\_. The purchaser (Buyer) shall have the privilege  
297 and option of proceeding with the consummation of this Contract without regard to the amount of the appraised valuation. The  
298 appraised valuation is arrived at to determine the maximum mortgage the Department of Housing and Urban Development will  
299 insure. HUD does not warrant the value nor the condition of the Property. The purchaser (Buyer) should satisfy  
300 himself/herself/themselves that the price and condition of the Property are acceptable.

301 **6.2.3. VA.** It is expressly agreed that, notwithstanding any other provisions of this Contract, the purchaser (Buyer)  
302 shall not incur any penalty by forfeiture of Earnest Money or otherwise or be obligated to complete the purchase of the Property  
303 described herein, if the Contract Purchase Price or cost exceeds the reasonable value of the Property established by the Department  
304 of Veterans Affairs. The purchaser (Buyer) shall, however, have the privilege and option of proceeding with the consummation of  
305 this Contract without regard to the amount of the reasonable value established by the Department of Veterans Affairs.

306 **6.3. Lender Property Requirements.** If the lender imposes any written requirements, replacements, removals or repairs,  
307 including any specified in the Appraisal (Lender Property Requirements) to be made to the Property (e.g., roof repair, repainting),  
308 beyond those matters already agreed to by Seller in this Contract, this Contract terminates on the earlier of three days following  
309 Seller's receipt of the Lender Property Requirements, or Closing, unless prior to termination: (1) the parties enter into a written  
310 agreement to satisfy the Lender Property Requirements; (2) the Lender Property Requirements have been completed; or (3) the  
311 satisfaction of the Lender Property Requirements is waived in writing by Buyer.

312 **6.4. Cost of Appraisal.** Cost of the Appraisal to be obtained after the date of this Contract must be timely paid by  **Buyer**  
313  **Seller.** The cost of the Appraisal may include any and all fees paid to the appraiser, appraisal management company, lender's  
314 agent or all three.

315 **7. OWNERS' ASSOCIATIONS.** This Section is applicable if the Property is located within one or more Common Interest  
316 Communities and subject to one or more declarations (Association).

317 **7.1. Common Interest Community Disclosure.** **THE PROPERTY IS LOCATED WITHIN A COMMON**  
318 **INTEREST COMMUNITY AND IS SUBJECT TO THE DECLARATION FOR THE COMMUNITY. THE OWNER OF**  
319 **THE PROPERTY WILL BE REQUIRED TO BE A MEMBER OF THE OWNERS' ASSOCIATION FOR THE**  
320 **COMMUNITY AND WILL BE SUBJECT TO THE BYLAWS AND RULES AND REGULATIONS OF THE**  
321 **ASSOCIATION. THE DECLARATION, BYLAWS AND RULES AND REGULATIONS WILL IMPOSE FINANCIAL**  
322 **OBLIGATIONS UPON THE OWNER OF THE PROPERTY, INCLUDING AN OBLIGATION TO PAY ASSESSMENTS**  
323 **OF THE ASSOCIATION. IF THE OWNER DOES NOT PAY THESE ASSESSMENTS, THE ASSOCIATION COULD**  
324 **PLACE A LIEN ON THE PROPERTY AND POSSIBLY SELL IT TO PAY THE DEBT. THE DECLARATION, BYLAWS**  
325 **AND RULES AND REGULATIONS OF THE COMMUNITY MAY PROHIBIT THE OWNER FROM MAKING**  
326 **CHANGES TO THE PROPERTY WITHOUT AN ARCHITECTURAL REVIEW BY THE ASSOCIATION (OR A**

327 COMMITTEE OF THE ASSOCIATION) AND THE APPROVAL OF THE ASSOCIATION. PURCHASERS OF  
328 PROPERTY WITHIN THE COMMON INTEREST COMMUNITY SHOULD INVESTIGATE THE FINANCIAL  
329 OBLIGATIONS OF MEMBERS OF THE ASSOCIATION. PURCHASERS SHOULD CAREFULLY READ THE  
330 DECLARATION FOR THE COMMUNITY AND THE BYLAWS AND RULES AND REGULATIONS OF THE  
331 ASSOCIATION.

332 **7.2. Association Documents to Buyer.** Seller is obligated to provide to Buyer the Association Documents (defined below),  
333 at Seller's expense, on or before **Association Documents Deadline**. Seller authorizes the Association to provide the Association  
334 Documents to Buyer, at Seller's expense. Seller's obligation to provide the Association Documents is fulfilled upon Buyer's receipt  
335 of the Association Documents, regardless of who provides such documents.

336 **7.3. Association Documents.** Association documents (Association Documents) consist of the following:

337 **7.3.1.** All Association declarations, articles of incorporation, bylaws, articles of organization, operating agreements,  
338 rules and regulations, party wall agreements and the Association's responsible governance policies adopted under § 38-33.3-209.5,  
339 C.R.S.;

340 **7.3.2.** Minutes of: (1) the annual owners' or members' meeting and (2) any executive boards' or managers' meetings;  
341 such minutes include those provided under the most current annual disclosure required under § 38-33.3-209.4, C.R.S. (Annual  
342 Disclosure) and minutes of meetings, if any, subsequent to the minutes disclosed in the Annual Disclosure. If none of the preceding  
343 minutes exist, then the most recent minutes, if any (§§ 7.3.1. and 7.3.2., collectively, Governing Documents); and

344 **7.3.3.** List of all Association insurance policies as provided in the Association's last Annual Disclosure, including,  
345 but not limited to, property, general liability, association director and officer professional liability and fidelity policies. The list must  
346 include the company names, policy limits, policy deductibles, additional named insureds and expiration dates of the policies listed  
347 (Association Insurance Documents);

348 **7.3.4.** A list by unit type of the Association's assessments, including both regular and special assessments as  
349 disclosed in the Association's last Annual Disclosure;

350 **7.3.5.** The Association's most recent financial documents which consist of: (1) the Association's operating budget  
351 for the current fiscal year, (2) the Association's most recent annual financial statements, including any amounts held in reserve for  
352 the fiscal year immediately preceding the Association's last Annual Disclosure, (3) the results of the Association's most recent  
353 available financial audit or review, (4) list of the fees and charges (regardless of name or title of such fees or charges) that the  
354 Association's community association manager or Association will charge in connection with the Closing including, but not limited  
355 to, any fee incident to the issuance of the Association's statement of assessments (Status Letter), any rush or update fee charged for  
356 the Status Letter, any record change fee or ownership record transfer fees (Record Change Fee), fees to access documents, (5) list of  
357 all assessments required to be paid in advance, reserves or working capital due at Closing and (6) reserve study, if any (§§ 7.3.4. and  
358 7.3.5., collectively, Financial Documents);

359 **7.3.6.** Any written notice from the Association to Seller of a "construction defect action" under § 38-33.3-303.5,  
360 C.R.S. within the past six months and the result of whether the Association approved or disapproved such action (Construction  
361 Defect Documents). Nothing in this Section limits the Seller's obligation to disclose adverse material facts as required under § 10.2.  
362 (Disclosure of Adverse Material Facts; Subsequent Disclosure; Present Condition) including any problems or defects in the common  
363 elements or limited common elements of the Association property.

364 **7.4. Conditional on Buyer's Review.** Buyer has the right to review the Association Documents. Buyer has the Right to  
365 Terminate under § 24.1., on or before **Association Documents Termination Deadline**, based on any unsatisfactory provision in  
366 any of the Association Documents, in Buyer's sole subjective discretion. Should Buyer receive the Association Documents after  
367 **Association Documents Deadline**, Buyer, at Buyer's option, has the Right to Terminate under § 24.1. by Buyer's Notice to  
368 Terminate received by Seller on or before ten days after Buyer's receipt of the Association Documents. If Buyer does not receive  
369 the Association Documents, or if Buyer's Notice to Terminate would otherwise be required to be received by Seller after **Closing**  
370 **Date**, Buyer's Notice to Terminate must be received by Seller on or before Closing. If Seller does not receive Buyer's Notice to  
371 Terminate within such time, Buyer accepts the provisions of the Association Documents as satisfactory and Buyer waives any Right  
372 to Terminate under this provision, notwithstanding the provisions of § 8.6. (Third Party Right to Purchase/Approve).

## 373 8. TITLE INSURANCE, RECORD TITLE AND OFF-RECORD TITLE.

### 374 8.1. Evidence of Record Title.

375  **8.1.1. Seller Selects Title Insurance Company.** If this box is checked, Seller will select the title insurance  
376 company to furnish the owner's title insurance policy at Seller's expense. On or before **Record Title Deadline**, Seller must furnish  
377 to Buyer, a current commitment for an owner's title insurance policy (Title Commitment), in an amount equal to the Purchase Price,  
378 or if this box is checked,  an **Abstract of Title** certified to a current date. Seller will cause the title insurance policy to be issued  
379 and delivered to Buyer as soon as practicable at or after Closing.

380  **8.1.2. Buyer Selects Title Insurance Company.** If this box is checked, Buyer will select the title insurance  
381 company to furnish the owner's title insurance policy at Buyer's expense. On or before **Record Title Deadline**, Buyer must furnish to  
382 Seller, a current commitment for owner's title insurance policy (Title Commitment), in an amount equal to the Purchase Price.

383 If neither box in § 8.1.1. or § 8.1.2. is checked, § 8.1.1. applies.



384 **8.1.3. Owner's Extended Coverage (OEC).** The Title Commitment  Will  Will Not contain Owner's  
385 Extended Coverage (OEC). If the Title Commitment is to contain OEC, it will commit to delete or insure over the standard exceptions  
386 which relate to: (1) parties in possession, (2) unrecorded easements, (3) survey matters, (4) unrecorded mechanics' liens, (5) gap  
387 period (period between the effective date and time of commitment to the date and time the deed is recorded) and (6) unpaid taxes,  
388 assessments and unredeemed tax sales prior to the year of Closing. Any additional premium expense to obtain OEC will be paid by  
389  Buyer  Seller  One-Half by Buyer and One-Half by Seller  Other \_\_\_\_\_.

390 Regardless of whether the Contract requires OEC, the Title Insurance Commitment may not provide OEC or delete or insure over  
391 any or all of the standard exceptions for OEC. The Title Insurance Company may require a New Survey or New ILC, defined below,  
392 among other requirements for OEC. If the Title Insurance Commitment is not satisfactory to Buyer, Buyer has a right to object under  
393 § 8.7. (Right to Object to Title, Resolution).

394 **8.1.4. Title Documents.** Title Documents consist of the following: (1) copies of any plats, declarations, covenants,  
395 conditions and restrictions burdening the Property and (2) copies of any other documents (or, if illegible, summaries of such  
396 documents) listed in the schedule of exceptions (Exceptions) in the Title Commitment furnished to Buyer (collectively, Title  
397 Documents).

398 **8.1.5. Copies of Title Documents.** Buyer must receive, on or before **Record Title Deadline**, copies of all Title  
399 Documents. This requirement pertains only to documents as shown of record in the office of the clerk and recorder in the county  
400 where the Property is located. The cost of furnishing copies of the documents required in this Section will be at the expense of the  
401 party or parties obligated to pay for the owner's title insurance policy.

402 **8.1.6. Existing Abstracts of Title.** Seller must deliver to Buyer copies of any abstracts of title covering all or any  
403 portion of the Property (Abstract of Title) in Seller's possession on or before **Record Title Deadline**.

404 **8.2. Record Title.** Buyer has the right to review and object to the Abstract of Title or Title Commitment and any of the  
405 Title Documents as set forth in § 8.7. (Right to Object to Title, Resolution) on or before **Record Title Objection Deadline**. Buyer's  
406 objection may be based on any unsatisfactory form or content of Title Commitment or Abstract of Title, notwithstanding § 13, or  
407 any other unsatisfactory title condition, in Buyer's sole subjective discretion. If the Abstract of Title, Title Commitment or Title  
408 Documents are not received by Buyer on or before the **Record Title Deadline**, or if there is an endorsement to the Title Commitment  
409 that adds a new Exception to title, a copy of the new Exception to title and the modified Title Commitment will be delivered to  
410 Buyer. Buyer has until the earlier of Closing or ten days after receipt of such documents by Buyer to review and object to: (1) any  
411 required Title Document not timely received by Buyer, (2) any change to the Abstract of Title, Title Commitment or Title Documents,  
412 or (3) any endorsement to the Title Commitment. If Seller receives Buyer's Notice to Terminate or Notice of Title Objection,  
413 pursuant to this § 8.2. (Record Title), any title objection by Buyer is governed by the provisions set forth in § 8.7. (Right to Object  
414 to Title, Resolution). If Seller has fulfilled all Seller's obligations, if any, to deliver to Buyer all documents required by § 8.1.  
415 (Evidence of Record Title) and Seller does not receive Buyer's Notice to Terminate or Notice of Title Objection by the applicable  
416 deadline specified above, Buyer accepts the condition of title as disclosed by the Abstract of Title, Title Commitment and Title  
417 Documents as satisfactory.

418 **8.3. Off-Record Title.** Seller must deliver to Buyer, on or before **Off-Record Title Deadline**, true copies of all existing  
419 surveys in Seller's possession pertaining to the Property and must disclose to Buyer all easements, liens (including, without  
420 limitation, governmental improvements approved, but not yet installed) or other title matters not shown by public records, of which  
421 Seller has actual knowledge (Off-Record Matters). This Section excludes any **New ILC** or **New Survey** governed under § 9 (New  
422 ILC, New Survey). Buyer has the right to inspect the Property to investigate if any third party has any right in the Property not shown  
423 by public records (e.g., unrecorded easement, boundary line discrepancy or water rights). Buyer's Notice to Terminate or Notice of  
424 Title Objection of any unsatisfactory condition (whether disclosed by Seller or revealed by such inspection, notwithstanding § 8.2.  
425 (Record Title) and § 13 (Transfer of Title-)), in Buyer's sole subjective discretion, must be received by Seller on or before **Off-  
426 Record Title Objection Deadline**. If an Off-Record Matter is received by Buyer after the **Off-Record Title Deadline**, Buyer has  
427 until the earlier of Closing or ten days after receipt by Buyer to review and object to such Off-Record Matter. If Seller receives  
428 Buyer's Notice to Terminate or Notice of Title Objection pursuant to this § 8.3. (Off-Record Title), any title objection by Buyer is  
429 governed by the provisions set forth in § 8.7. (Right to Object to Title, Resolution). If Seller does not receive Buyer's Notice to  
430 Terminate or Notice of Title Objection by the applicable deadline specified above, Buyer accepts title subject to such Off-Record  
431 Matters and rights, if any, of third parties not shown by public records of which Buyer has actual knowledge.

432 **8.4. Special Taxing and Metropolitan Districts.** SPECIAL TAXING DISTRICTS MAY BE SUBJECT TO  
433 GENERAL OBLIGATION INDEBTEDNESS THAT IS PAID BY REVENUES PRODUCED FROM ANNUAL TAX LEVIES  
434 ON THE TAXABLE PROPERTY WITHIN SUCH DISTRICTS. PROPERTY OWNERS IN SUCH DISTRICTS MAY BE  
435 PLACED AT RISK FOR INCREASED MILL LEVIES AND TAX TO SUPPORT THE SERVICING OF SUCH DEBT  
436 WHERE CIRCUMSTANCES ARISE RESULTING IN THE INABILITY OF SUCH A DISTRICT TO DISCHARGE SUCH  
437 INDEBTEDNESS WITHOUT SUCH AN INCREASE IN MILL LEVIES. BUYERS SHOULD INVESTIGATE THE  
438 SPECIAL TAXING DISTRICTS IN WHICH THE PROPERTY IS LOCATED BY CONTACTING THE COUNTY  
439 TREASURER, BY REVIEWING THE CERTIFICATE OF TAXES DUE FOR THE PROPERTY AND BY OBTAINING  
440 FURTHER INFORMATION FROM THE BOARD OF COUNTY COMMISSIONERS, THE COUNTY CLERK AND  
441 RECORDER, OR THE COUNTY ASSESSOR. The official website for the Metropolitan District, if any, is: \_\_\_\_\_.

442 **8.5. Tax Certificate.** A tax certificate paid for by  Seller  Buyer, for the Property listing any special taxing or  
443 metropolitan districts that affect the Property (Tax Certificate) must be delivered to Buyer on or before **Record Title Deadline**. If  
444 the content of the Tax Certificate is unsatisfactory to Buyer, in Buyer's sole subjective discretion, Buyer may terminate, on or before  
445 **Record Title Objection Deadline**. Should Buyer receive the Tax Certificate after **Record Title Deadline**, Buyer, at Buyer's option,  
446 has the Right to Terminate under § 24.1. by Buyer's Notice to Terminate received by Seller on or before ten days after Buyer's  
447 receipt of the Tax Certificate. If Buyer does not receive the Tax Certificate, or if Buyer's Notice to Terminate would otherwise be  
448 required to be received by Seller after **Closing Date**, Buyer's Notice to Terminate must be received by Seller on or before Closing.  
449 If Seller does not receive Buyer's Notice to Terminate within such time, Buyer accepts the content of the Tax Certificate as  
450 satisfactory and Buyer waives any Right to Terminate under this provision. If Buyer's loan specified in §4.5.3. (Loan Limitations)  
451 prohibits Buyer from paying for the Tax Certificate, the Tax Certificate will be paid for by Seller.

452 **8.6. Third Party Right to Purchase/Approve.** If any third party has a right to purchase the Property (e.g., right of first  
453 refusal on the Property, right to purchase the Property under a lease or an option held by a third party to purchase the Property) or a  
454 right of a third party to approve this Contract, Seller must promptly submit this Contract according to the terms and conditions of  
455 such right. If the third-party holder of such right exercises its right this Contract will terminate. If the third party's right to purchase  
456 is waived explicitly or expires, or the Contract is approved, this Contract will remain in full force and effect. Seller must promptly  
457 notify Buyer in writing of the foregoing. If the third party right to purchase is exercised or approval of this Contract has not occurred  
458 on or before **Third Party Right to Purchase/Approve Deadline**, this Contract will then terminate. Seller will supply to Buyer, in  
459 writing, details of any Third Party Right to Purchase the Property on or before the Record Title Deadline.

460 **8.7. Right to Object to Title, Resolution.** Buyer has a right to object or terminate, in Buyer's sole subjective discretion,  
461 based on any title matters including those matters set forth in § 8.2. (Record Title), § 8.3. (Off-Record Title), § 8.5. (Tax Certificate)  
462 and § 13 (Transfer of Title). If Buyer exercises Buyer's rights to object or terminate based on any such title matter, on or before the  
463 applicable deadline, Buyer has the following options:

464 **8.7.1. Title Objection, Resolution.** If Seller receives Buyer's written notice objecting to any title matter (Notice of  
465 Title Objection) on or before the applicable deadline and if Buyer and Seller have not agreed to a written settlement thereof on or  
466 before **Title Resolution Deadline**, this Contract will terminate on the expiration of **Title Resolution Deadline**, unless Seller receives  
467 Buyer's written withdrawal of Buyer's Notice of Title Objection (i.e., Buyer's written notice to waive objection to such items and  
468 waives the Right to Terminate for that reason), on or before expiration of **Title Resolution Deadline**. If either the Record Title  
469 Deadline or the Off-Record Title Deadline, or both, are extended pursuant to § 8.2. (Record Title) or § 8.3. (Off-Record Title) the  
470 Title Resolution Deadline also will be automatically extended to the earlier of Closing or fifteen days after Buyer's receipt of the  
471 applicable documents; or

472 **8.7.2. Title Objection, Right to Terminate.** Buyer may exercise the Right to Terminate under § 24.1., on or before  
473 the applicable deadline, based on any title matter unsatisfactory to Buyer, in Buyer's sole subjective discretion.

474 **8.8. Title Advisory.** The Title Documents affect the title, ownership and use of the Property and should be reviewed  
475 carefully. Additionally, other matters not reflected in the Title Documents may affect the title, ownership and use of the Property,  
476 including, without limitation, boundary lines and encroachments, set-back requirements, area, zoning, building code violations,  
477 unrecorded easements and claims of easements, leases and other unrecorded agreements, water on or under the Property and various  
478 laws and governmental regulations concerning land use, development and environmental matters.

498 **8.8.5. Title Insurance Exclusions.** Matters set forth in this Section and others, may be excepted, excluded from, or  
499 not covered by the owner's title insurance policy.

500 **8.9. Mineral Rights Review.** ~~Buyer  Does  Does Not have~~Buyer has a Right to Terminate if examination of the  
501 Mineral Rights is unsatisfactory to Buyer on or before the **Mineral Rights Examination Deadline**.

502 **9. NEW ILC, NEW SURVEY.**

529 or before **New ILC or New Survey Resolution Deadline**, this Contract will terminate on expiration of the **New ILC or New Survey**

540 facts will be in writing. In the event Seller discovers an adverse material fact after the date of this Contract, Seller must timely  
541 disclose such adverse fact to Buyer. Buyer has the Right to Terminate based on the Seller's new disclosure on the earlier of Closing  
542 or five days after Buyer's receipt of the new disclosure. Except as otherwise provided in this Contract, Buyer acknowledges that  
543 Seller is conveying the Property and Inclusions to Buyer in an "As Is" condition, "Where Is" and "With All Faults."

544 **10.3. Inspection.** Unless otherwise provided in this Contract, Buyer, acting in good faith, has the right to have inspections  
545 (by one or more third parties, personally or both) of the Property, Leased Items, and Inclusions (Inspection), at Buyer's expense. If

605 **10.6.2. Due Diligence Documents Review and Objection.** Buyer has the right to review and object based on the Due  
606 Diligence Documents. If the Due Diligence Documents are not supplied to Buyer or are unsatisfactory, in Buyer's sole subjective  
607 discretion, Buyer may, on or before **Due Diligence Documents Objection Deadline**:

608 **10.6.2.1. Notice to Terminate.** Notify Seller in writing, pursuant to § 24.1., that this Contract is  
609 terminated; or

610 **10.6.2.2. Due Diligence Documents Objection.** Deliver to Seller a written description of any

636 **10.10. Lead-Based Paint.**

637 **10.10.1. Lead-Based Paint Disclosure.** Unless exempt, if the Property includes one or more residential dwellings  
638 constructed or a building permit was issued prior to January 1, 1978, for the benefit of Buyer, Seller and all required real estate  
639 licensees must sign and deliver to Buyer a completed Lead-Based Paint Disclosure (Sales) form on or before the **Lead-Based Paint**

644 Property for the presence of Lead-Based Paint or Lead-Based Paint hazards, Buyer has a Right to Terminate under § 24.1\_ by Seller's  
645 receipt of Buyer's Notice to Terminate on or before the expiration of the **Lead-Based Paint Termination Deadline**. Buyer may  
646 elect to waive Buyer's right to conduct or obtain a risk assessment or inspection of the Property for the presence of Lead-Based Paint  
647 or Lead-Based Paint hazards. If Seller does not receive Buyer's Notice to Terminate within such time, Buyer accepts the condition  
648 of the Property relative to any Lead-Based Paint as satisfactory and Buyer waives any Right to Terminate under this provision.

667 **RESIDENTIAL REAL PROPERTY MAY PRESENT EXPOSURE TO DANGEROUS LEVELS OF INDOOR RADON**  
668 **GAS THAT MAY PLACE THE OCCUPANTS AT RISK OF DEVELOPING RADON-INDUCED LUNG CANCER.**  
669 **RADON, A CLASS A HUMAN CARCINOGEN, IS THE LEADING CAUSE OF LUNG CANCER IN NONSMOKERS**  
670 **AND THE SECOND LEADING CAUSE OF LUNG CANCER OVERALL. THE SELLER OF RESIDENTIAL REAL**

671 **PROPERTY IS REQUIRED TO PROVIDE THE BUYER WITH ANY KNOWN INFORMATION ON RADON TEST**  
672 **RESULTS OF THE RESIDENTIAL REAL PROPERTY.**

673 **AN ELECTRONIC COPY OF THE MOST RECENT BROCHURE PUBLISHED BY THE DEPARTMENT OF**

679 **11. COLORADO FORECLOSURE PROTECTION ACT.** The Colorado Foreclosure Protection Act (Act) generally applies

696 **12. CLOSING DOCUMENTS, INSTRUCTIONS AND CLOSING.**

697 **12.1. Closing Documents and Closing Information.** Seller and Buyer will cooperate with the Closing Company to enable  
698 the Closing Company to prepare and deliver documents required for Closing to Buyer and Seller and their designees. If Buyer is

804 **18. CAUSES OF LOSS, INSURANCE; DAMAGE TO INCLUSIONS AND SERVICES; CONDEMNATION; AND**  
805 **WALK-THROUGH.** Except as otherwise provided in this Contract, the Property, and Inclusions ~~or both~~ will be delivered in the  
806 condition existing as of the date of this Contract, ordinary wear and tear excepted.

807 **18.1. Causes of Loss, Insurance.** In the event the Property or Inclusions are damaged by fire, other perils or causes of loss  
808 prior to Closing (Property Damage) in an amount of not more than ten percent of the total Purchase Price and if the repair of the  
809 damage will be paid by insurance (other than the deductible to be paid by Seller), then Seller, upon receipt of the insurance proceeds,  
810 will use Seller's reasonable efforts to repair the Property before **Closing Date**. Buyer has the Right to Terminate under § 24.1., on  
811 or before **Closing Date**, if the Property is not repaired before **Closing Date**, or if the damage exceeds such sum. Should Buyer elect  
812 to carry out this Contract despite such Property Damage, Buyer is entitled to a credit at Closing for all insurance proceeds that were

841 **19. RECOMMENDATION OF LEGAL AND TAX COUNSEL.** By signing this Contract, Buyer and Seller acknowledge that  
842 their respective broker has advised that this Contract has important legal consequences and has recommended: (1) legal examination  
843 of title; (2) consultation with legal and tax or other counsel before signing this Contract as this Contract may have important legal  
844 and tax implications; (3) to consult with their own attorney if Water Rights, Mineral Rights or Leased Items are included or excluded  
845 in the sale; and (4) to consult with legal counsel if there are other matters in this transaction for which legal counsel should be  
846 engaged and consulted. Such consultations must be done timely as this Contract has strict time limits, including deadlines, that must

849 **20. TIME OF ESSENCE, DEFAULT AND REMEDIES.** Time is of the essence for all dates and deadlines in this Contract.  
850 This means that all dates and deadlines are strict and absolute. If any payment due, including Earnest Money, is not paid, honored  
851 or tendered when due, or if any obligation is not performed timely as provided in this Contract or waived, the non-defaulting party  
852 has the following remedies:

853 **20.1. If Buyer is in Default:**

854  **20.1.1. Specific Performance.** Seller may elect to cancel this Contract and all Earnest Money (whether or not paid  
855 by Buyer) will be paid to Seller and retained by Seller. It is agreed that the Earnest Money is not a penalty, and the parties agree the  
856 amount is fair and reasonable. Seller may recover such additional damages as may be proper. Alternatively, Seller may elect to treat  
857 this Contract as being in full force and effect and Seller has the right to specific performance or damages, or both.

858 **20.1.2. Liquidated Damages, Applicable.** This § 20.1.2. applies unless the box in § 20.1.1. is checked. Seller may  
859 cancel this Contract. All Earnest Money (whether or not paid by Buyer) will be paid to Seller and retained by Seller. It is agreed that  
860 the Earnest Money amount specified in § 4.1. is LIQUIDATED DAMAGES and not a penalty, which amount the parties agree is  
861 fair and reasonable and (except as provided in §§ 10.4. and 21), such amount is SELLER'S ONLY REMEDY for Buyer's failure to  
862 perform the obligations of this Contract. Seller expressly waives the remedies of specific performance and additional damages.

863 **20.2. If Seller is in Default:**

864 **20.2.1. Specific Performance, Damages or Both.** Buyer may elect to treat this Contract as canceled, in which case  
865 all Earnest Money received hereunder will be returned to Buyer and Buyer may recover such damages as may be proper.  
866 Alternatively, in addition to the per diem in § 17 (Possession) for failure of Seller to timely deliver possession of the Property after  
867 Closing occurs, Buyer may elect to treat this Contract as being in full force and effect and Buyer has the right to specific performance  
868 or damages, or both.

869 **20.2.2. Seller's Failure to Perform.** In the event Seller fails to perform Seller's obligations under this Contract, to  
870 include, but not limited to, failure to timely disclose Association violations known by Seller, failure to perform any replacements or  
871 repairs required under this Contract or failure to timely disclose any known adverse material facts, Seller remains liable for any such  
872 failures to perform under this Contract after Closing. Buyer's rights to pursue the Seller for Seller's failure to perform under this  
873 Contract are reserved and survive Closing.

874 **21. LEGAL FEES, COST AND EXPENSES.** Anything to the contrary herein notwithstanding, in the event of any arbitration  
875 or litigation relating to this Contract, prior to or after **Closing Date**, the arbitrator or court must award to the prevailing party all  
876 reasonable costs and expenses, including attorney fees, legal fees and expenses.

877 **22. MEDIATION.** If a dispute arises relating to this Contract (whether prior to or after Closing) and is not resolved, the parties  
878 must first proceed, in good faith, to mediation. Mediation is a process in which the parties meet with an impartial person who helps  
879 to resolve the dispute informally and confidentially. Mediators cannot impose binding decisions. Before any mediated settlement is  
880 binding, the parties to the dispute must agree to the settlement, in writing. The parties will jointly appoint an acceptable mediator  
881 and will share equally in the cost of such mediation. The obligation to mediate, unless otherwise agreed, will terminate if the entire  
882 dispute is not resolved within thirty days of the date written notice requesting mediation is delivered by one party to the other at that  
883 party's last known address (physical or electronic as provided in § 26). Nothing in this Section prohibits either party from filing a  
884 lawsuit and recording a *lis pendens* affecting the Property, before or after the date of written notice requesting mediation. This  
885 Section will not alter any date in this Contract, unless otherwise agreed.

886 **23. EARNEST MONEY DISPUTE.** Except as otherwise provided herein, Earnest Money Holder must release the Earnest  
887 Money following receipt of written mutual instructions, signed by both Buyer and Seller. In the event of any controversy regarding  
888 the Earnest Money, Earnest Money Holder is not required to release the Earnest Money. Earnest Money Holder, in its sole subjective

889 discretion, has several options: (1) wait for any proceeding between Buyer and Seller; (2) interplead all parties and deposit Earnest  
890 Money into a court of competent jurisdiction (Earnest Money Holder is entitled to recover court costs and reasonable attorney and  
891 legal fees incurred with such action); or (3) provide notice to Buyer and Seller that unless Earnest Money Holder receives a copy of  
892 the Summons and Complaint or Claim (between Buyer and Seller) containing the case number of the lawsuit (Lawsuit) within one

897 **24. TERMINATION.**

898 **24.1. Right to Terminate.** If a party has a right to terminate, as provided in this Contract (Right to Terminate), the  
899 termination is effective upon the other party's receipt of a written notice to terminate (Notice to Terminate), provided such written  
900 notice was received on or before the applicable deadline specified in this Contract. If the Notice to Terminate is not received on or  
901 before the specified deadline, the party with the Right to Terminate accepts the specified matter, document or condition as satisfactory  
902 and waives the Right to Terminate under such provision. Any Notice to Terminate delivered after the applicable deadline specified

906 **25. ENTIRE AGREEMENT, MODIFICATION, SURVIVAL; SUCCESSORS.** This Contract, its exhibits and specified  
907 addenda, constitute the entire agreement between the parties relating to the subject hereof and any prior agreements pertaining  
908 thereto, whether oral or written, have been merged and integrated into this Contract. No subsequent modification of any of the terms  
909 of this Contract is valid, binding upon the parties, or enforceable unless made in writing and signed by the parties. Any right or  
910 obligation in this Contract that, by its terms, exists or is intended to be performed after termination or Closing survives the same.  
911 Any successor to a party receives the predecessor's benefits and obligations of this Contract.

912 **26. NOTICE, DELIVERY AND CHOICE OF LAW.**

913 **26.1. Physical Delivery and Notice.** Any document or notice to Buyer or Seller must be in writing, except as provided in  
914 § 26.2. and is effective when physically received by such party, any individual named in this Contract to receive documents or  
915 notices for such party, Broker, or Brokerage Firm of Broker working with such party (except any notice or delivery after Closing  
916 must be received by the party, not Broker or Brokerage Firm).

917 **26.2. Electronic Notice.** As an alternative to physical delivery, any notice may be delivered in electronic form to Buyer or  
918 Seller, any individual named in this Contract to receive documents or notices for such party, Broker or Brokerage Firm of Broker  
919 working with such party (except any notice or delivery after Closing, cancellation or Termination must be received by the party, not  
920 Broker or Brokerage Firm) at the electronic address of the recipient by facsimile, email or \_\_\_\_\_.

921 **26.3. Electronic Delivery.** Electronic Delivery of documents and notice may be delivered by: (1) email at the email address  
922 of the recipient, (2) a link or access to a website or server provided the recipient receives the information necessary to access the  
923 documents, or (3) facsimile at the facsimile number (Fax No.) of the recipient.

924 **26.4. Choice of Law.** This Contract and all disputes arising hereunder are governed by and construed in accordance with  
925 the laws of the State of Colorado that would be applicable to Colorado residents who sign a contract in Colorado for real property  
926 located in Colorado.

927 **27. NOTICE OF ACCEPTANCE, COUNTERPARTS.** This proposal will expire unless accepted in writing, by Buyer and  
928 Seller, as evidenced by their signatures below and the offering party receives notice of such acceptance pursuant to § 26 on or before  
929 **Acceptance Deadline Date and Acceptance Deadline Time.** If accepted, this document will become a contract between Seller and  
930 Buyer. A copy of this Contract may be executed by each party, separately and when each party has executed a copy thereof, such  
931 copies taken together are deemed to be a full and complete contract between the parties.

932 **28. GOOD FAITH.** Buyer and Seller acknowledge that each party has an obligation to act in good faith including, but not limited

934 **Record Title and Off-Record Title; New ILC, New Survey; and Property Disclosure, Inspection, Indemnity, Insurability Due**

936 **29. BUYER'S BROKERAGE FIRM COMPENSATION.** Buyer's brokerage firm's compensation will be paid, at Closing, as  
937 follows:
